UPDATE: Redwood Collaborative Nomination Process

One or two people on the Nominating Committee from each county:

- $^{\circ}$ review the tracking spreadsheet
- \circ identify remaining openings in each category
- add nominations from their county to the spreadsheet with an equity lens
- recruit nominees using consistent messaging/materials

Once the nominee agrees, they are **appointed** with no further discussion.

- If a nominee doesn't agree, invite participation in planning process
- Move to next organization on list

Goal: representation from each county in each of the 13 categories.


Proposed Structure for Initial Leadership Group

Team of Teams

Initial Leadership Task: Ensure community participation in planning effort.

Teams focus on important topics to include in the regional plan.

Teams invite wider community participation in planning.



Partnership Agreement Letter

One letter that spells out agreements of all organizations on the Redwood Economic Collaborative.

- Commitment to support CERF goals
- Describes Governance Structure of Collaborative
- Describes decision-making process

Separate signature page from each organization's representative

• Why/how the organization offers equitable representation

Governance Structure: Proposal Requirements

Captures diversity of the region

Commitment to shared authority and responsibility

Commitment to shifting power

Democratic, participatory decisions

Proposed Sociocratic Governance Structure


Team of Teams

Work is organized into domains.

Each domain has clear description of authority and responsibilities.

Domain teams have high degree of autonomy.

- Team makes decisions on how work is done (e.g., sub-groups, individuals)
- Smaller groups encourage listening, relationships, trust, collaboration.



Sociocratic Governance Supports Consensus Process

Opening Out: Share needs, concerns, desires, emotions.

Discussion: Explore ideas. Be curious, listen closely, try to understand others' needs and concerns.

- Ask questions, gather information.
- Facilitate the discussion in rounds so all voices are heard.

Synthesis: Find common ground and build proposals weaving together different ideas.

• Proposals should address fundamental needs and key concerns.

From the Call:

1. Explains the relevant dynamics in the CERF Region that the HRTC will be navigating, including the following:

- Identifying major industries, economic shifts, challenges and opportunities related to shared economic growth and prosperity.
- Identifying major economic development projects or initiatives that have impacted or continue to impact communities and industries in the region.
- 2. Identifies complementary economic development or planning processes ongoing in the CERF Region and possible areas of collaboration or integration with CERF.
- 1. Describes how the HRTC will address geographic equity and ensure participation from and collaborative decision-making with disinvested communities.

From the Call:



"Successful applications must use a combination of quantitative and qualitative supporting data as applicable from a variety of reliable sources that demonstrate the socio-economic, climate, and community-wide factors that inform the application...

...relevant data sources include the EDD LMID, BLS, local surveys...consultation with industry associations, local jurisdictions, or mandatory and non-mandatory partners...use local data sources that illustrate the experience of individuals and specific communities, local news articles or social media groups, data from interviews, focus group sessions, or surveys..."



• Doesn't exist.

Rural data constraints

- Can't disaggregate to relevant unit or population.
- Biases against marginalized, remote communitiesfrequently researched but still "data poor".

Wildfire, drought, sea level rise are the most cited vulnerabilities for our counties.





Percent working poor by race/ethnicity: United States vs. Humboldt, CA; Poverty: Below 100%; Workers: Full-time workers; Year: 2019







